2025 Port Royal Community Charitable Fund Grants \$142,400

Annual grants are awarded to local nonprofits that meet requirements consistent with those of Community Foundation of the Lowcountry. These grants are based on available funds and current needs in the community. Applications are reviewed by a team of Port Royal residents so that, through careful vetting and accountability in reporting, we can ensure that our funds are truly helping to improve the lives of people in the Lowcountry.

Mission & Purpose

PRCCF has a three-pronged mission:

- To encourage and support the charitable, caring interests of the Port Royal landowners
- To enhance the sense of community among Port Royal residents by having our own charitable fund
- To leverage resources in order to have a larger impact in the greater community.

PRCCF's purpose is to provide grants to benefit our neighbors in Beaufort, Hampton, Jasper, and Colleton counties; to respond to people in need; and to provide resources to help improve the lives of people in the Lowcountry.

Port Royal Community Charitable Fund Makes Us Proud

It's time to reflect on the completion of another successful year, built upon the experiences of our first three years. This year, we have once again exceeded our fundraising and grant goals.

These are not just PRCCF accomplishments but are a measure of our collective success. It is the product of Community Foundation of the Lowcountry support, without whom we would not exist, the 57 Founders who gave us a huge jump start, the 350 + Port Royal families whose donations over the years have sustained it, and the 62 business partners and sponsors that have joined us over these years with their contributions.

This year we:

- Issued \$142,400 in grants to 10 to local non-profits. In our first 4 years we have awarded 39 grants for \$375,285.
- Continued to sponsor direct drives for food and supplies to support local communities: Chimney Cove and Second Helpings, SERG Group's effort to help the victims of Hurricane Helene and the Sandalwood Community
- Continued to grow the sustainability fund that was established and has been invested to provide longer term philanthropic support.
- Nominated a founder and former member of its Advisory Board, Kaye Black, for the Joan and Wade Webster Community Impact Award which was awarded to her by the Community Foundation of the Lowcountry.
- Had some fun in the process by sponsoring Susan Diamond Riley's History of Hilton Head Island last fall and the Showcase of Homes House Tour this past spring.

We will once again kick off our annual fundraising campaign for this fiscal year which began on July 1, 2025. There are always opportunities to serve on the Advisory Board, on one of our committees or help at one of our events. No donation of time, money or talent is too small.

I know that it is important to all of us to find ways to give something of our own good fortunes back to those in need. It is also important that we build and maintain friendships in the best place on the island to live, and in one that is increasingly recognized as a generous and caring community. We do this through the Port Royal Community Charitable Fund.
